INTRODUCTION

The 2000 **Travel Report** covers information on travel in and out of Dominica for the last ten years. This report presents data on visitor port of entry, airline and sea vessel activities, country of residence, length and place of stay, purpose of visit and cruise arrivals. The aim of this **annual** report is to assist interested persons, establishments, firms or institutions in readily recognizing visitor/tourist trends in Dominica. This report will help identify chief, potential and untapped markets and also provide information on the flow, activity and market share of main aircraft and sea vessels.

Periodically, relevant information will be added and slight changes will be made in the contents of these reports. Therefore, all suggestions from users that can assist us in improving future issues will be welcomed.

The Central Statistical Office is grateful for the co-operation it has received from the Immigration Department, the Canefield and Melville Hall Airports, the Division of Tourism and the various cruise and airline agencies.

EXPLANATORY NOTES

THE FOLLOWING DEFINITIONS HAVE BEEN USED IN THIS REPORT

TOURISM: Tourism denotes the temporary, short movements of people to destinations outside the places where they normally live and work, for other than business or vocational reasons and their activities during the stay at these destinations.

Tourism represents various types of short-term travel and visits and is variously defined for particular purposes, by reference to the purpose of the journey, its duration and other criteria.

VISITORS: A visitor is a non-resident person (national or alien) usually resident abroad, who enters Dominica and intends to stay for not more than one year for non-immigrant purposes such as touring, recreation, leisure, business, study or family reasons. Visitors have been divided into the following categories:

- (i) **TOURIST:** Any person who stays at least one night but not more than 365 nights in land accommodations.
- (ii) **EXCURSIONIST:** Any person who does not stay for any one night in any land accommodations.

Hence, an excursionist may either be a flight passenger who departs from Dominica on the same day he arrives, or a boat passenger who sleeps on board the vessel in a port of Dominica.

RESIDENT: Any person (national or alien) who has been residing or has been given permission to reside for more than one year and who has not yet been abroad for more than one year.

TOURISTS ARE SUB-DIVIDED AS FOLLOWS:

1. Holiday visitors whose purpose of visit is expressly stated as vacation. These visitors are classified either as staying in hotels, guesthouses or cottages, or as staying in private homes (i.e. with friends or relatives).
2. Business visitors who come for private as well as governmental business purposes. Included also are research workers from international institutions such the U.N., the I.M.F. and the CARICOM Secretariat.
3. Students who are permitted to enter to pursue a course of study at a school or university.
4. Other visitors, that is, visitors not covered by the previous three categories.

THE COUNTRY GROUPINGS USED IN THE TABLES ARE DEFINED AS FOLLOWS:

O.E.C.S.:	Antigua, Dominica, Grenada, Montserrat, St. Kitts/Nevis, St. Lucia and St. Vincent
OTHER CARICOM:	Barbados, Belize, Guyana, Jamaica and Trinidad & Tobago
FRENCH WEST INDIES:	Martinique, Guadeloupe, The Saints, St. Martin and St.Bartholomew
SCANDINAVIA:	Norway, Sweden, Denmark with dependencies, Finland and Iceland

2000 TRAVEL REVIEW

Visitor arrivals numbered 72,254 for the year 2000, recording a 6.7 percent decline over the previous year (Table 1A). The Canadian market reflected a minimal 0.5 percent increase, while the Caribbean, Europe and United States registered percentage decreases of 8.5, 7.1, and 3.7 respectively.

Over the year 58.4 percent of all visitors to Dominica came from Caribbean islands with the French West Indies accounting for 29.1 percent (Table 1). The United States accounted for 21.0 percent followed by Europe, 15.8 percent.

Air and sea arrivals stood at 69.0 and 31.0 percent respectively, reflecting a similar trend to that of last year. The Melville Hall airport registered 59.0 percent of all visitor arrivals compared 56.7 percent last year (Table 2). LIAT remains the leading airline in spite of a steady decrease in market share since 1998. American Eagle, the second leading airline recorded 28.5 percent of all air visitors. The operations of two new airlines over the year, the EC Express (from April) and Caribbean Star (from October), accounted for 7.0 percent and 1.7 percent of air visitors respectively (Table 3). The reduction in flight operation of Helen Air resulted in a significant percentage decrease, 90.4, over the year.

Over the year, the Roseau seaport registered 30.4 percent of all visitor arrivals while Portsmouth in the north accounted for 0.3 percent of visitor arrivals. Anse de Mai recorded 171 visitors, the highest since 1993 when 176 were registered. The Express Des Isles vessels continue to dominate the market recording 96.1 percent of all sea visitors. Brudey Freres registered a decline in market share registering 2.0 percent in comparison to 5.0 percent in the last year.

The month of July registered the highest monthly arrival, 9,344 for the year. A significant decline was noted for October in comparison to last year. This was partly attributed to the higher inflow of visitors during the reunion year of 1999.

Tourist arrivals decreased 5.3 percent over the last year (Table 8B). Decreases were recorded in all major markets. A 7.1 percent decline was registered in Europe, followed by the Caribbean, 6.4 percent and the United States, 3.4 percent. Canada reflected a minimal 0.8 percent rise. Twenty percent of all tourists from the United States came from New York and 11.5 percent from Florida (Table 8A). California and Texas accounted for 6.9 and 4.0 percent respectively. Compared to last year significant percentage increases were recorded from Maryland, 54.7; New Jersey, 31.0 and Pennsylvania, 23.5.

Ontario, Canada registered a 51.5 percent increase and represented 34.6 percent of all Canadian tourists. Quebec increased 141.7 percent over last year.

Within Europe, percentage decreases were noted from the United Kingdom, 7.4; France, 3.6 and Germany, 14.2. Increases were registered in Denmark/Norway, 12.0 percent and Italy, 11.2 percent.

Latin American reflected a 35.5 percent rise mainly as a result of an increasing number of tourist arrivals from Venezuela.

A 55.1 percent decline was recorded in tourists from Taiwan while the number from China increased significantly.

The 4-7 day period remains the most popular length of stay for tourist representing 32.1 percent of all tourists. The 15-21 days stay rose by 69.8 percent over last year. Forty-two percent of all tourists stayed in paid accommodations compared to 39.3 percent last year. Of all tourists in paid accommodation 47.5 percent were at hotels and 25.6 percent at guesthouses, (Tables 13A & 13B). The percentage of tourists at private homes registered 54.8 compared to 55.8 last year. Of all tourists, nationals recorded 11.9 percent while non-nationals accounted for 88.1 percent (Table 16A).

Excursionist arrivals declined 32.3 percent over last year with all major markets registering decreases. However, increases were recorded for France, 33.8%; and Holland 33.3% (Table 19A).

Total passenger arrivals recorded a 3.0 percent fall while passenger departures registered a minimal 0.50 percent decrease (Table 23). Cruise arrivals registered 239,796 reflecting an 18.7 percent rise over the last year.

VISITOR ARRIVALS BY COUNTRY OF RESIDENCE: 2000

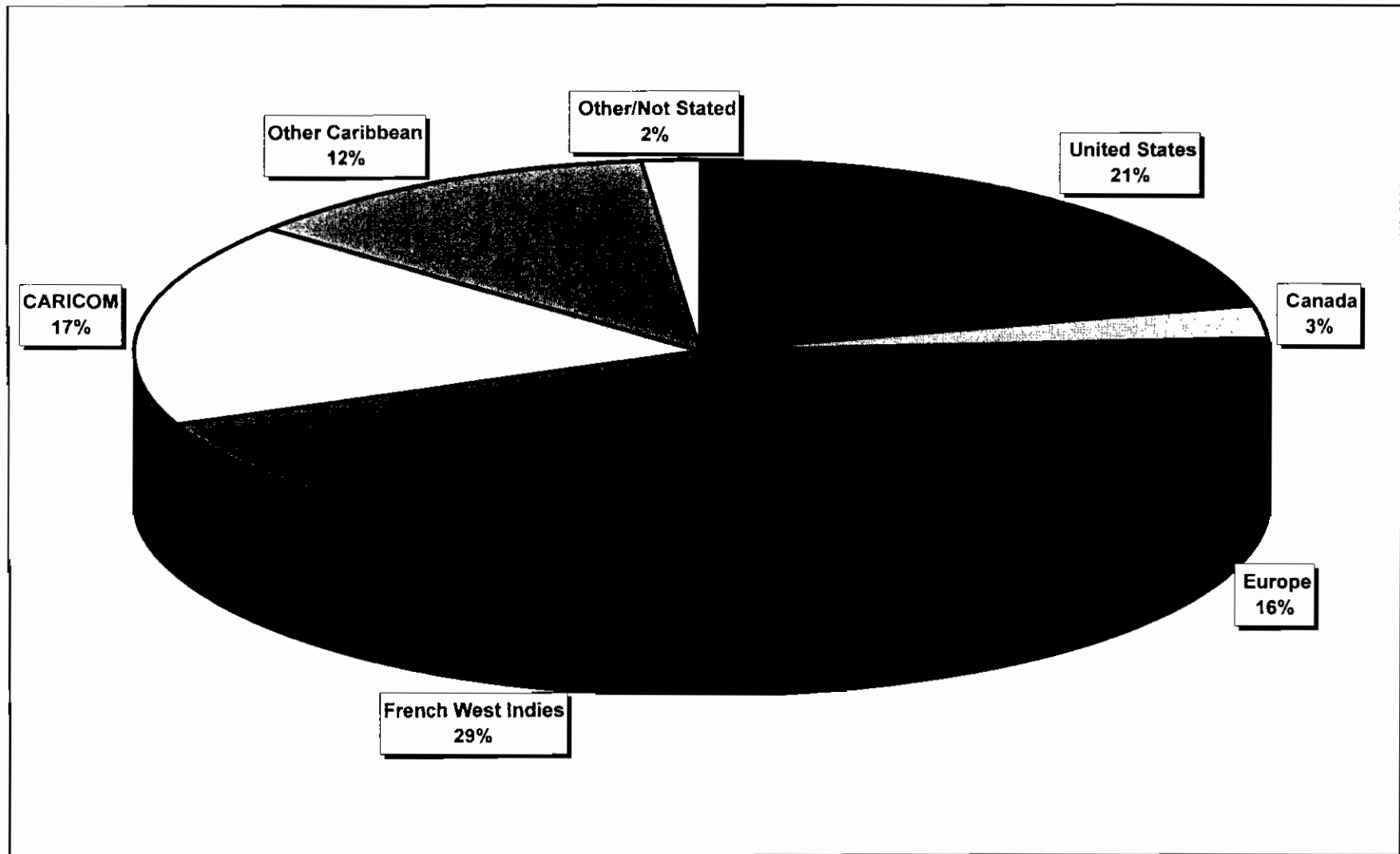

1996 - 2000

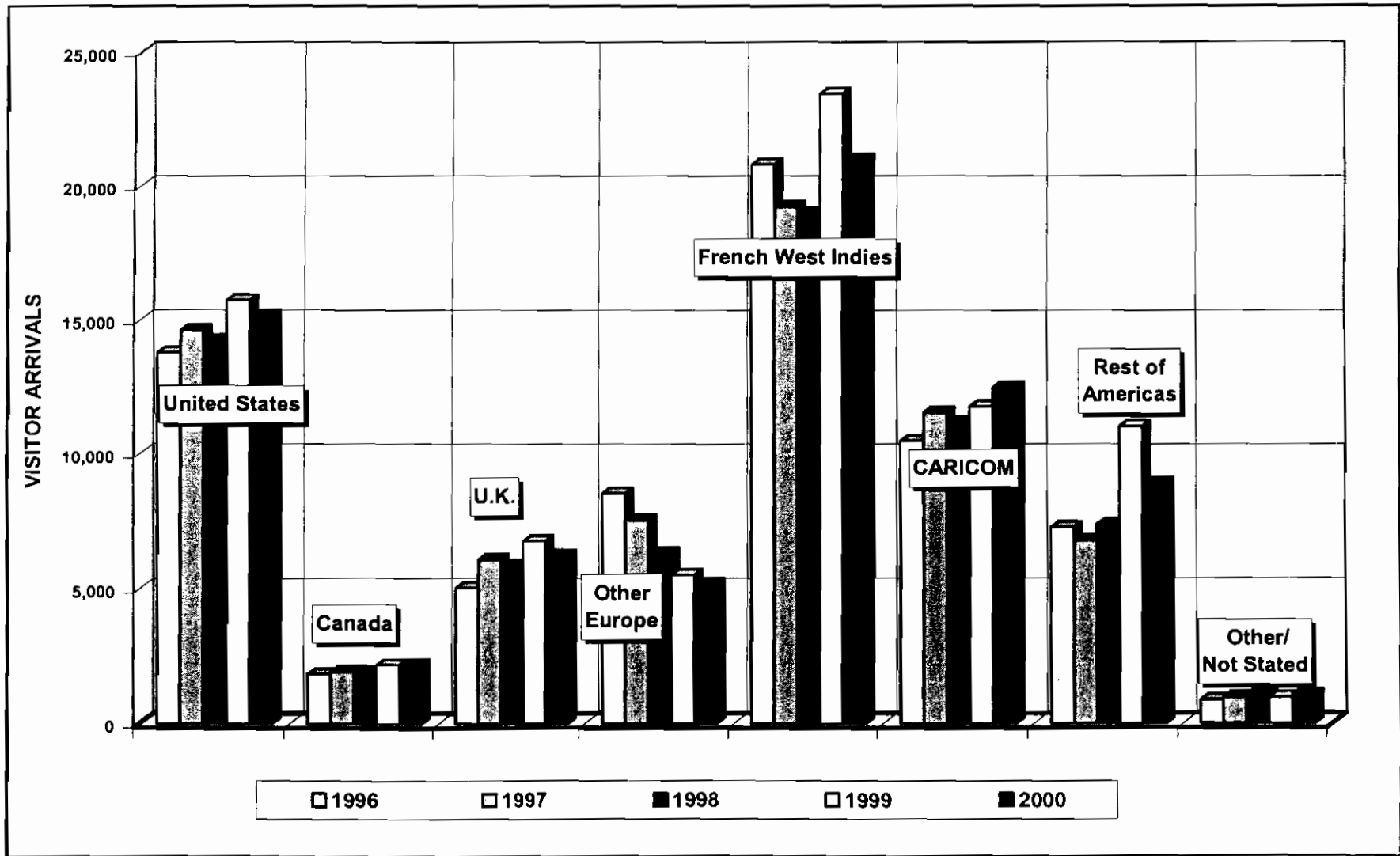

VISITOR ARRIVALS: 1991 - 2000

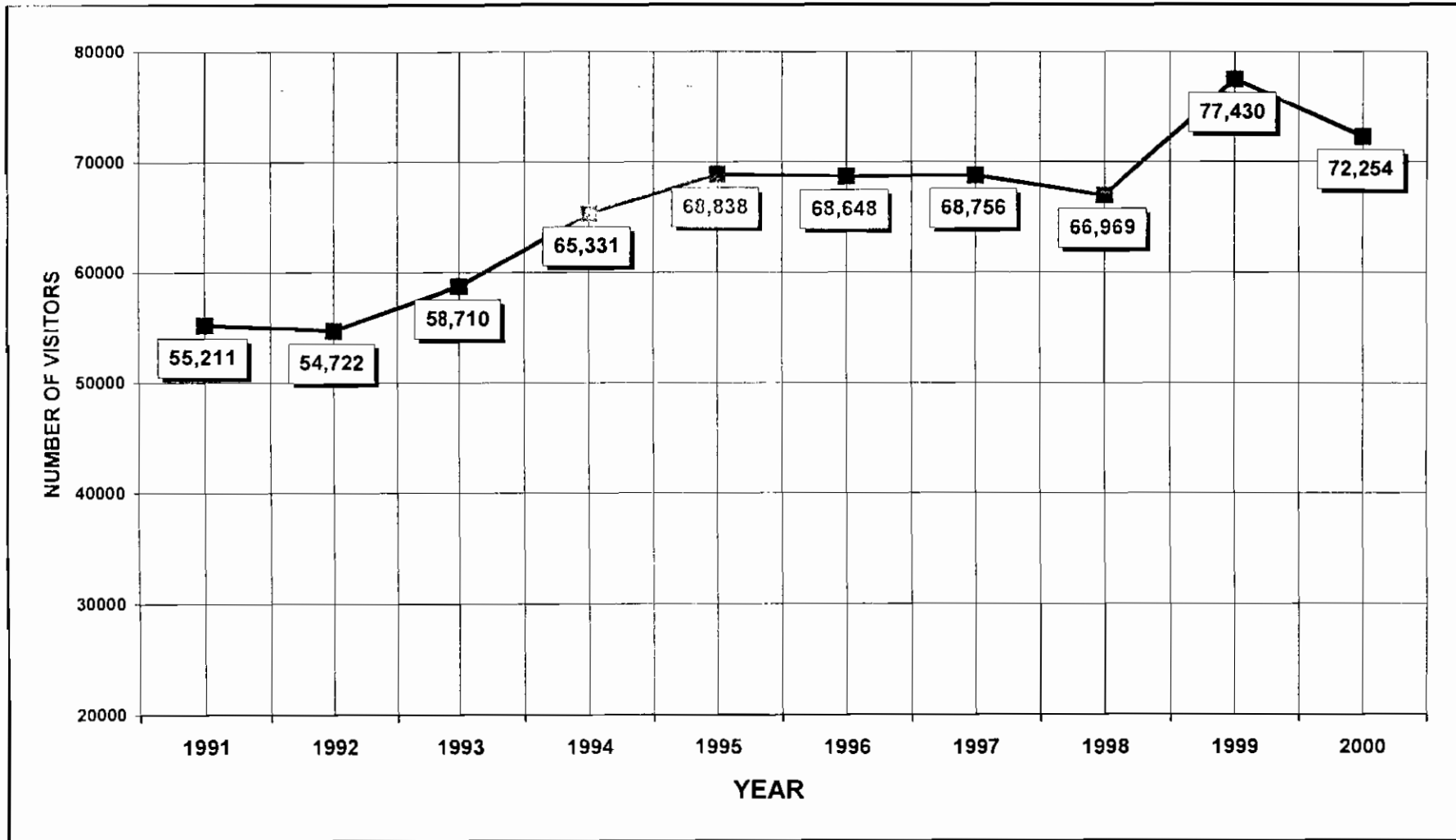


CHART 4

1996 - 2000

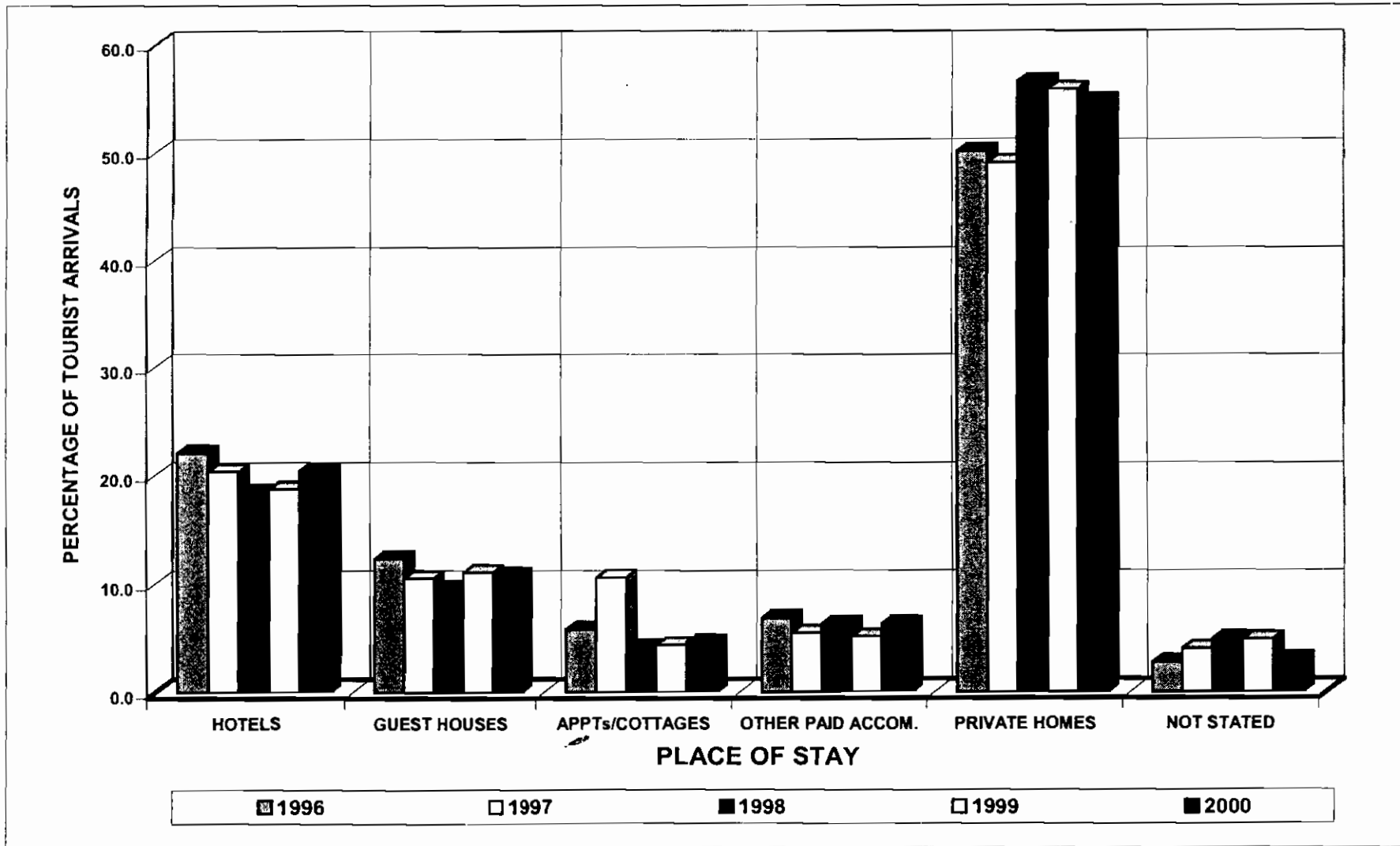

1996 - 2000

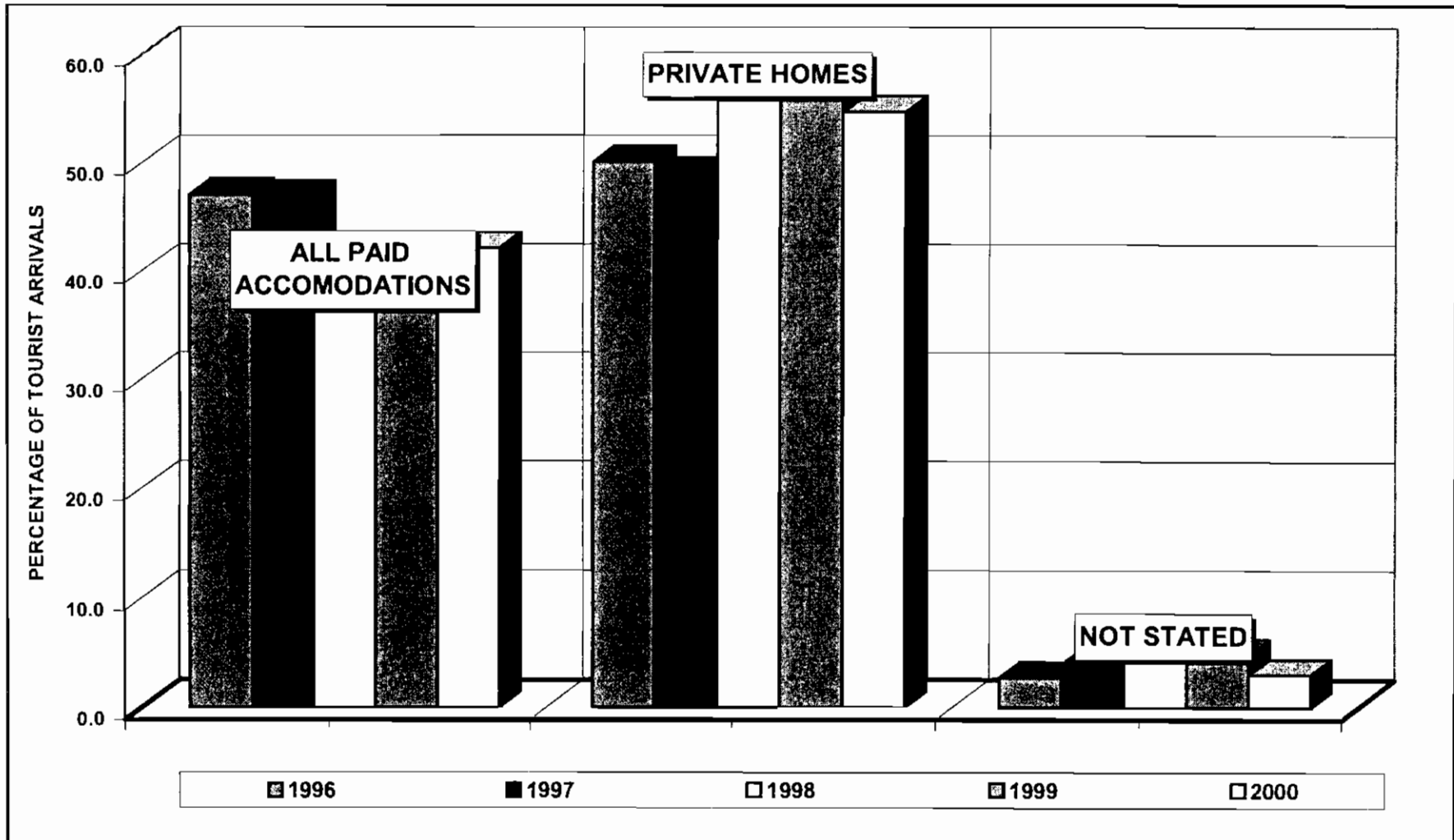

2000

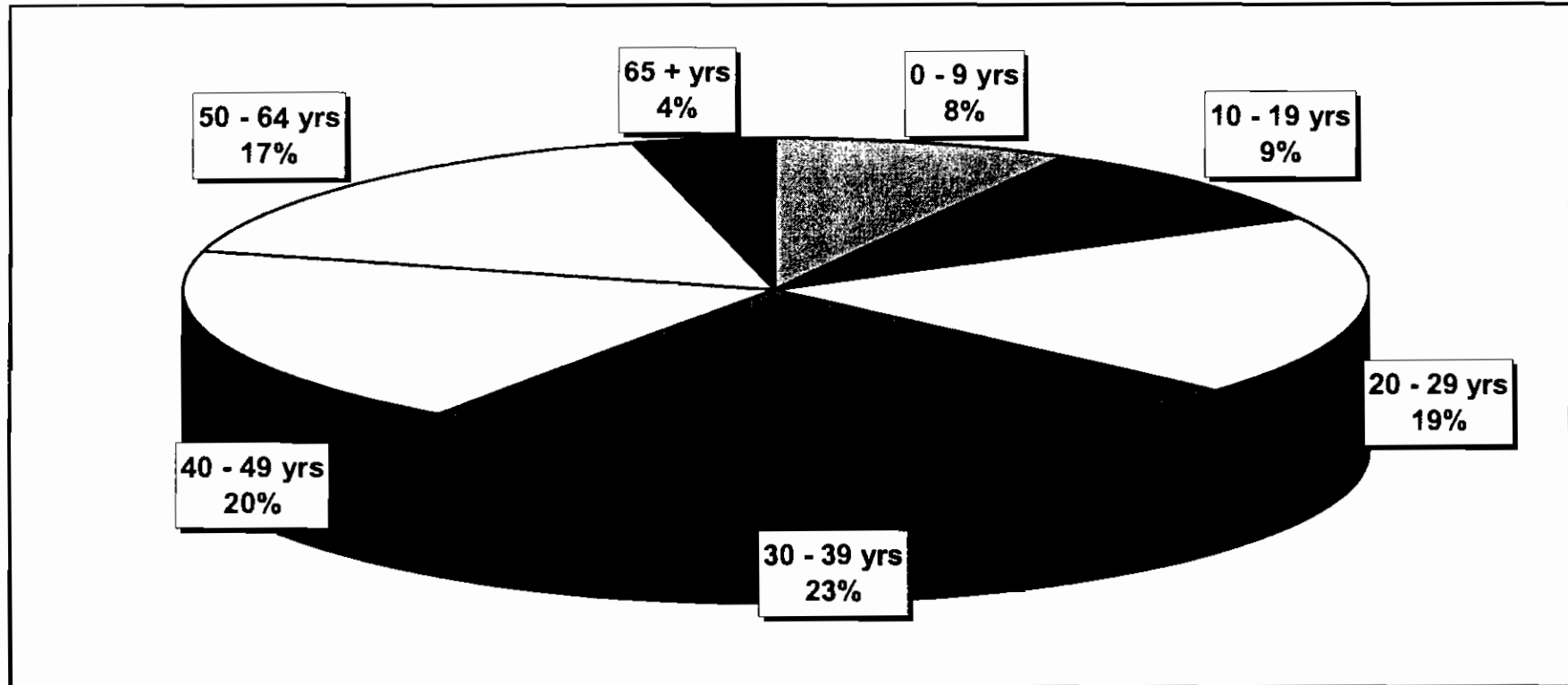

NUMBER OF EXCURSIONISTS: 1991 - 2000

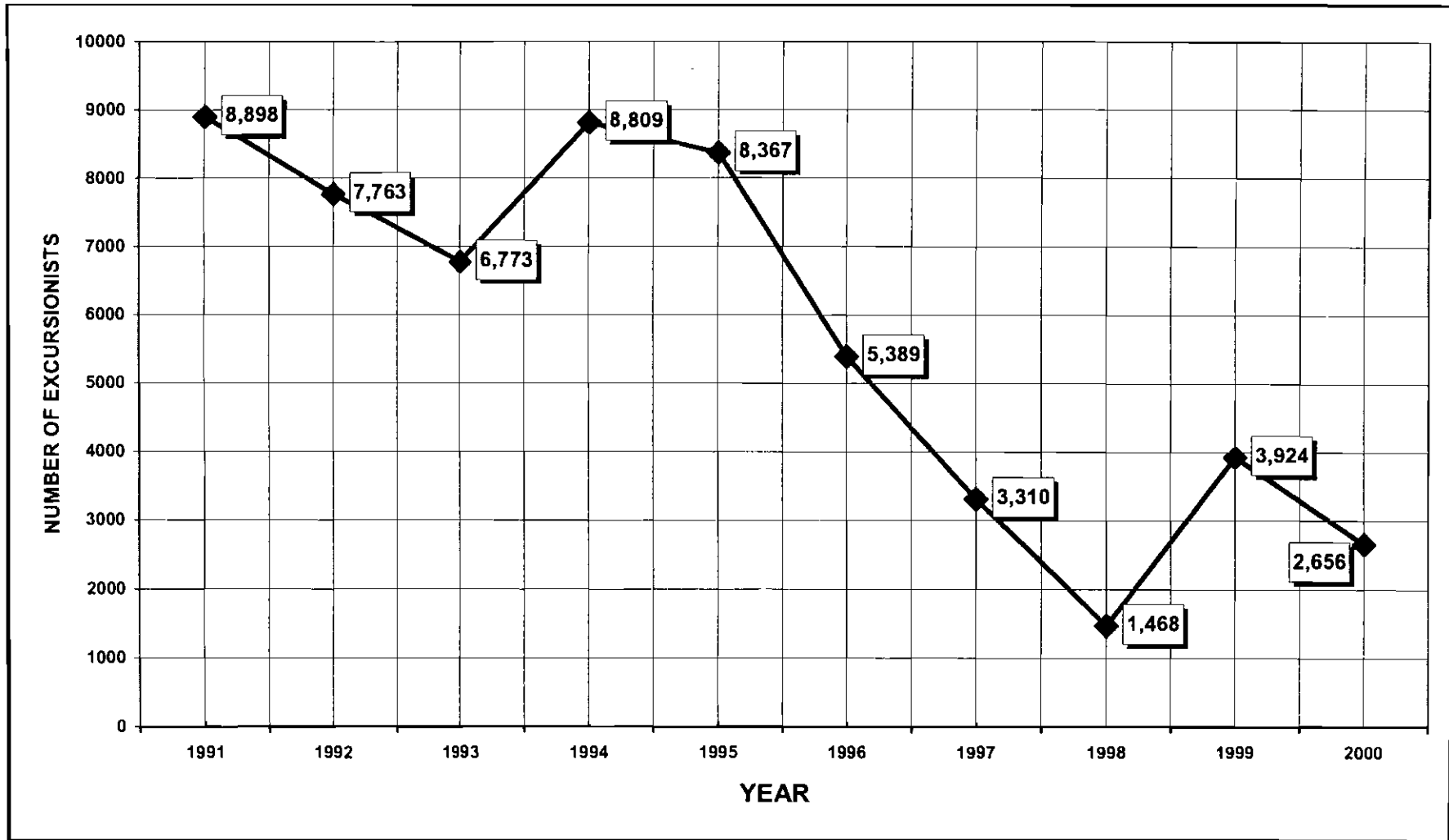


CHART 8

CRUISESHIP ARRIVALS : 1991 - 2000

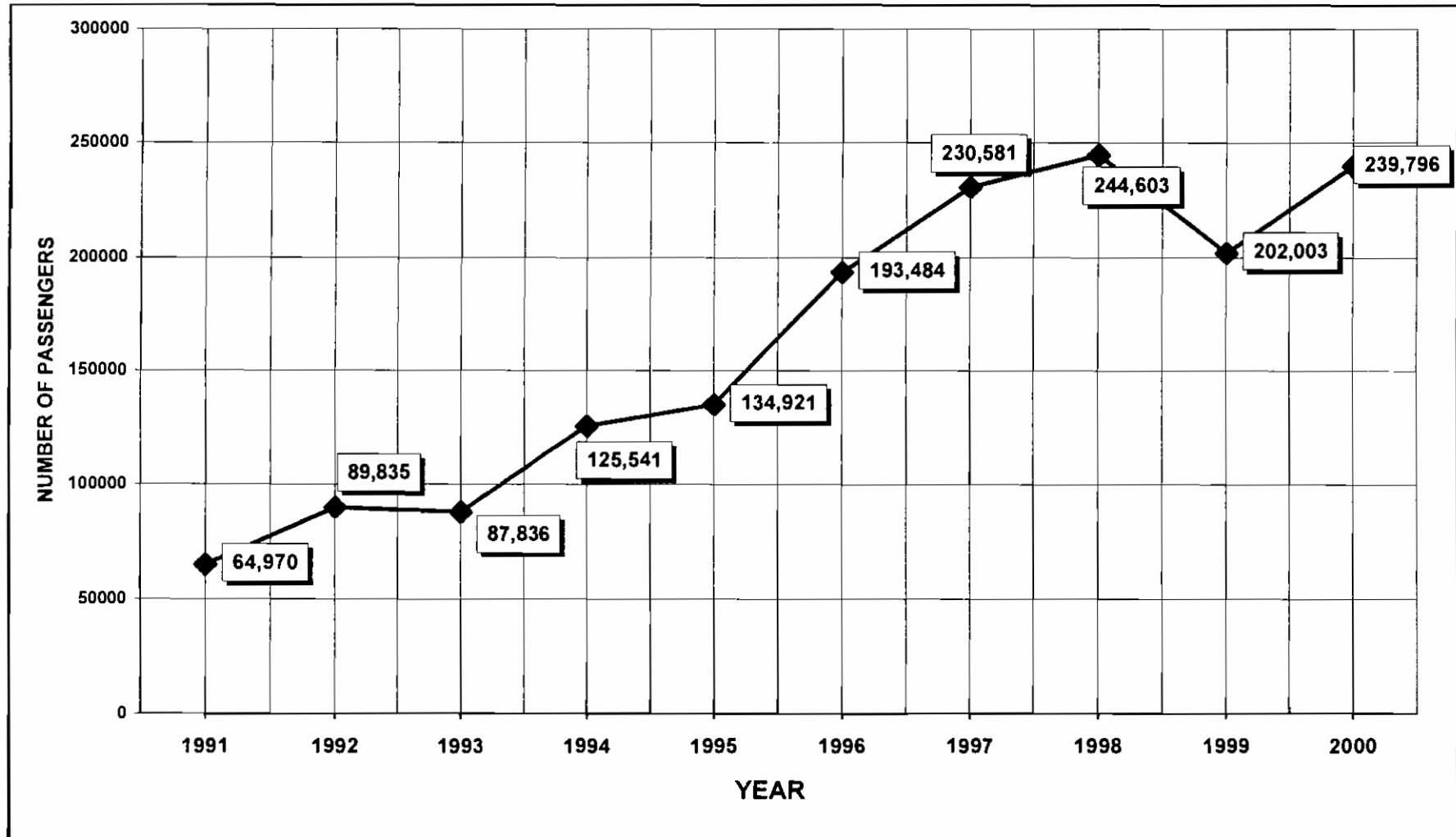
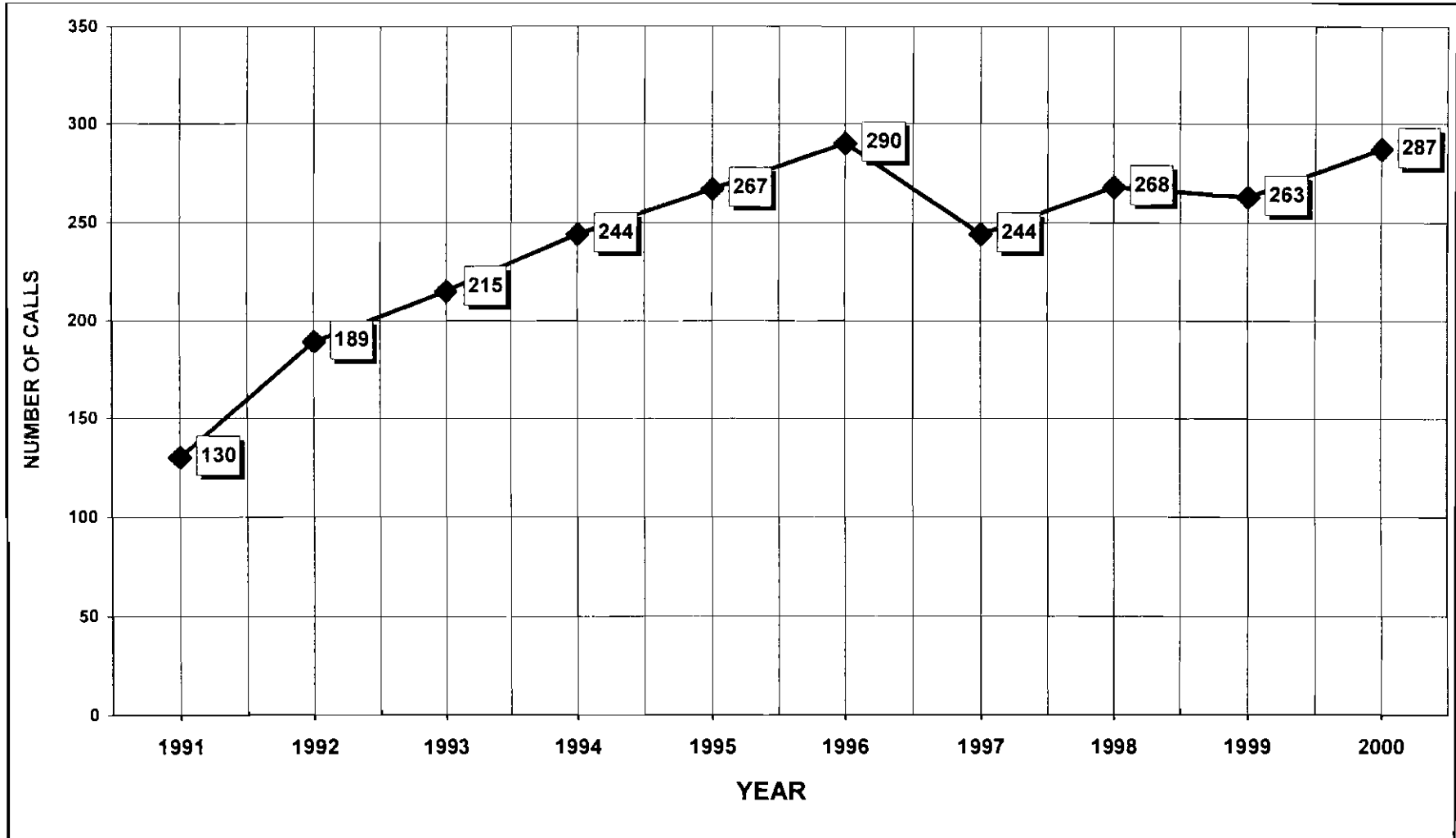


CHART 9
