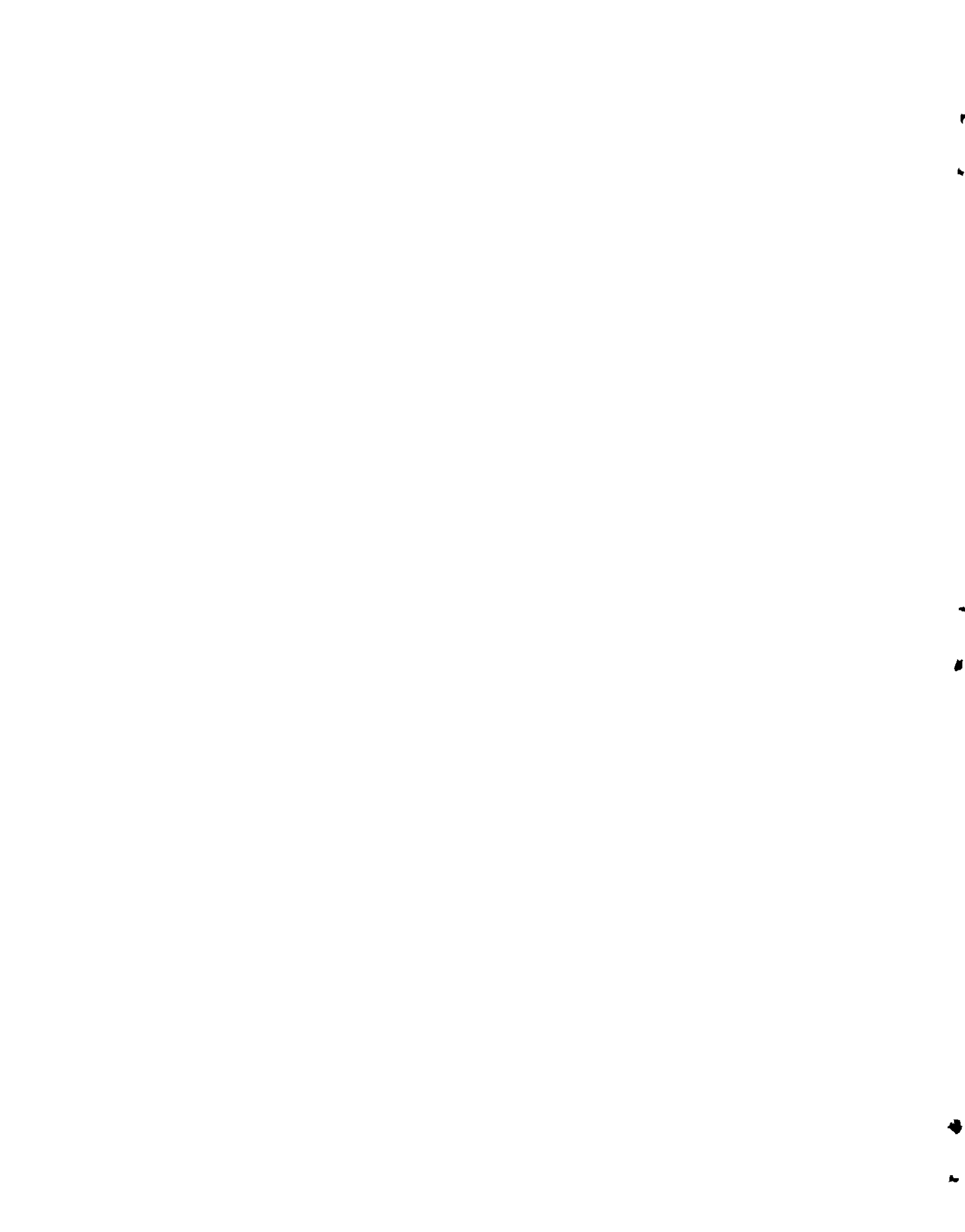
INTRODUCTION

The **2006 Travel Report** covers information on travel in and out of Dominica for the last ten years. This report presents data on visitor port of entry, airline and sea vessel activities, country of residence, length and place of stay, purpose of visit and cruise arrivals. The aim of this **annual** report is to assist interested persons, establishments, firms or institutions in readily recognizing visitor/tourist trends in Dominica. This report will help identify chief, potential and untapped markets and also provide information on the flow, activity and market share of main aircraft and sea vessels.

EXPLANATORY NOTES

THE FOLLOWING DEFINITIONS HAVE BEEN USED IN THIS REPORT

TOURISM: Tourism denotes the temporary, short movements of people to destinations outside the places where they normally live and work, for other than business or vocational reasons and their activities during the stay at these destinations.

Tourism represents various types of short-term travel and visits and is variously defined for particular purposes, by reference to the purpose of the journey, its duration and other criteria.

VISITORS: A visitor is a non-resident person (national or alien) usually resident abroad, who enters Dominica and intends to stay for not more than one year for non-immigrant purposes such as touring, recreation, leisure, business, study or family reasons. Visitors have been divided into the following categories:

- (i) **TOURIST:** Any person who stays at least one night but not more than 365 nights in land accommodations.
- (ii) **EXCURSIONIST:** Any person who does not stay for any one night in any land accommodations.

Hence, an excursionist may either be a flight passenger who departs from Dominica on the same day he arrives, or a boat passenger who sleeps on board the vessel in a port of Dominica.

RESIDENT: Any person (national or alien) who has been residing or has been given permission to reside for more than one year and who has not yet been abroad for more than one year.

TOURISTS ARE SUB-DIVIDED AS FOLLOWS:

1. Holiday visitors whose purpose of visit is expressly stated as vacation. These visitors are classified either as staying in hotels, guesthouses or cottages, or as staying in private homes (i.e. with friends or relatives).
2. Business visitors who come for private as well as governmental business purposes. Included also are research workers from international institutions such the U.N., the I.M.F. and the CARICOM Secretariat.
3. Students who are permitted to enter to pursue a course of study at a school or university.
4. Other visitors, that is, visitors not covered by the previous three categories.

O.E.C.S.:	Antigua, Dominica, Grenada, Montserrat, St. Kitts/Nevis, St. Lucia and St. Vincent
OTHER CARICOM:	Barbados, Belize, Guyana, Jamaica and Trinidad & Tobago
FRENCH WEST INDIES:	Martinique, Guadeloupe, The Saints, St. Martin and St. Bartholomew
SCANDINAVIA:	Norway, Sweden, Denmark with dependencies, Finland and Iceland

TRAVEL REVIEW

Total visitors arriving into Dominica in 2006 registered to 84,967 recording a growth of 6.3 percent. Tourists and excursionists recorded percentage increases of 6.0 and 42.5 respectively. The number of cruise ship calls increased to 34.1 percent consequently resulting in a 25.9 percent rise in cruise passengers.

The increase in the number of visitors to Dominica came primarily from the Caribbean 55.7 percent, United States 26.0 percent and Europe 13.4 percent. In the Caribbean region, Other Caricom and OECS countries recorded growth of 31.1 percent and 15.7 percent respectively while the Other Caribbean (excluding the French West Indies) registered a decrease of 30.9 percent. The United States registered a 19.1 percent growth, while the European market increased by 10.2 percent. Other Europe increased by 31.5 percent, Scandinavia, 21.1 percent and France 20.8 percent, (Table 1A). Customarily, the months of July and September recorded the highest and lowest number of arrivals respectively (Table 7).

Air arrivals rose by 5.19 percent, accounting for 72.5 percent of visitors, while arrivals by sea increased by 9.45 percent. Caribbean Star airline transported 31.4 percent of visitors by air, while Liat followed closely with 28.9 percent. American Eagle registered 21.9 percent, moving down from the 24.5 percent in the last year. Express Des Iles was the main carrier for sea arrivals with 96.7 percent of sea visitors.

Tourist arrivals moved to 84,041 recording a 6.0 percent increase of 6.0 over 2005. The highest percentage growth was registered in the Canadian market 29.1 percent. United States followed with 19.0 percent and Europe 10.2 percent. Tourist arrivals to the Caribbean Countries dropped by 1.2 percent due primarily to a decline in Other Caribbean countries (not withstanding the increases in Other Caricom 30.0 percent OECS countries and 15.7 percent).

Tourists from Canada, Europe and United States stayed on an average 11-13 days in comparison to the overall 9.2 days of intended average length of stay. The Caribbean tourist recorded an average length of stay of 7.5 days (Table 9). Holiday was the primary reason for tourist travel recording 83.2 percent followed by business 10.0 percent. Arrivals for study increased by 16.5 percent as Dominica welcomed the opening of another off-shore medical school. Consequently visitors in paid accommodation increased to 41.3 percent from 33.8 percent over the same period last year. Tourists staying in private homes accounted for 57.5 percent (down from a steady increase in the last five years). Hotels registered 23.6 percent up from a 19.7 percent in the last year.

Excursionist increased by 42.5 percent over 2005 moving from 650 to 926 arrivals. French West Indies accounted for 73.9 percent of a total 685 excursionists, recording 47.6 percent increase over last year (Table 19A).

Cruise arrivals in 2006 increased from 301511 to 379643 recording growth of 25.91 percent in passengers and 34.1 percent in calls. January recorded the highest number of calls and passengers with 53 and 56038 respectively while September registered the lowest, 6 calls and 12361 passengers (Table 24A).

VISITOR ARRIVALS BY COUNTRY OF RESIDENCE: 2006

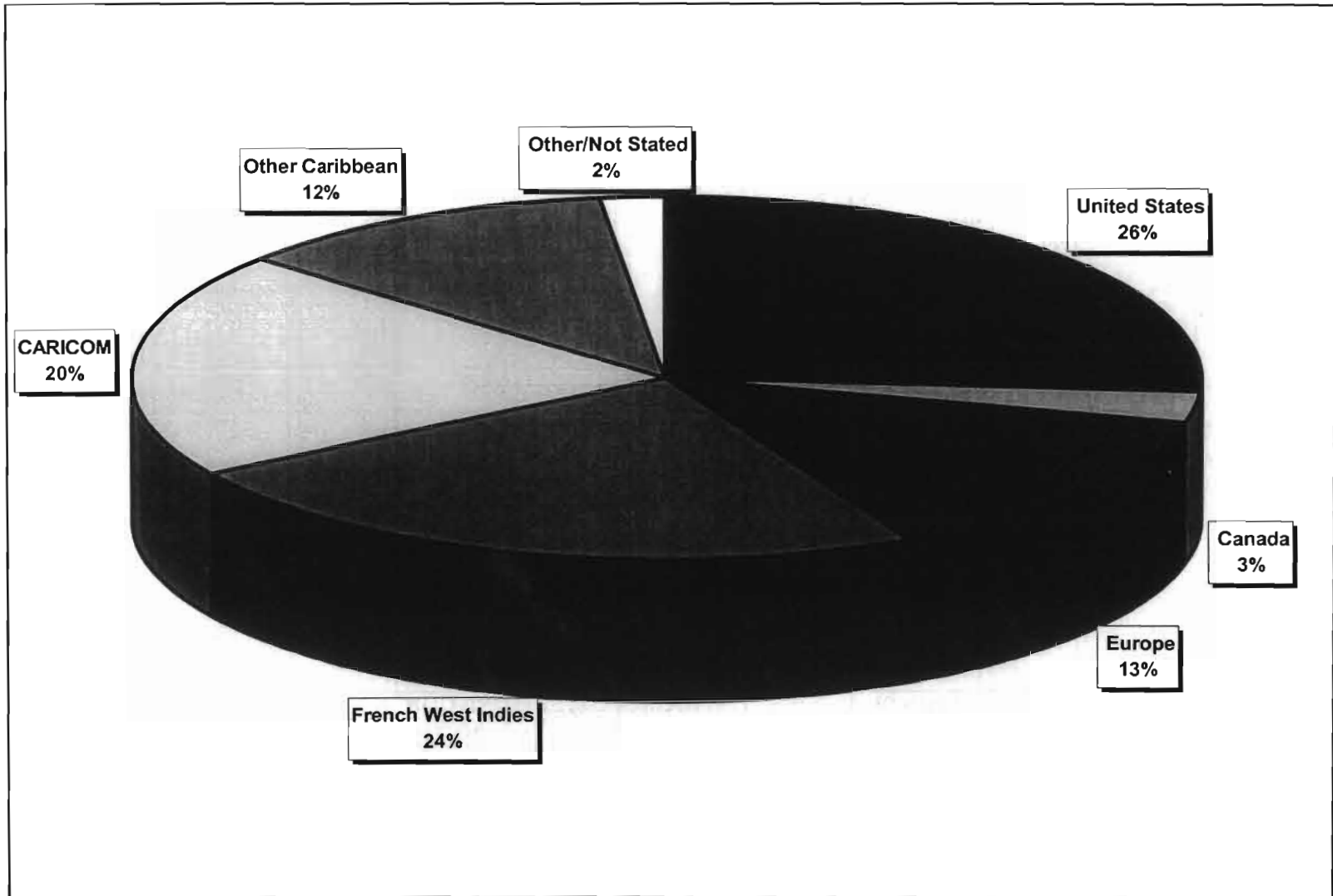

2002 - 2006**

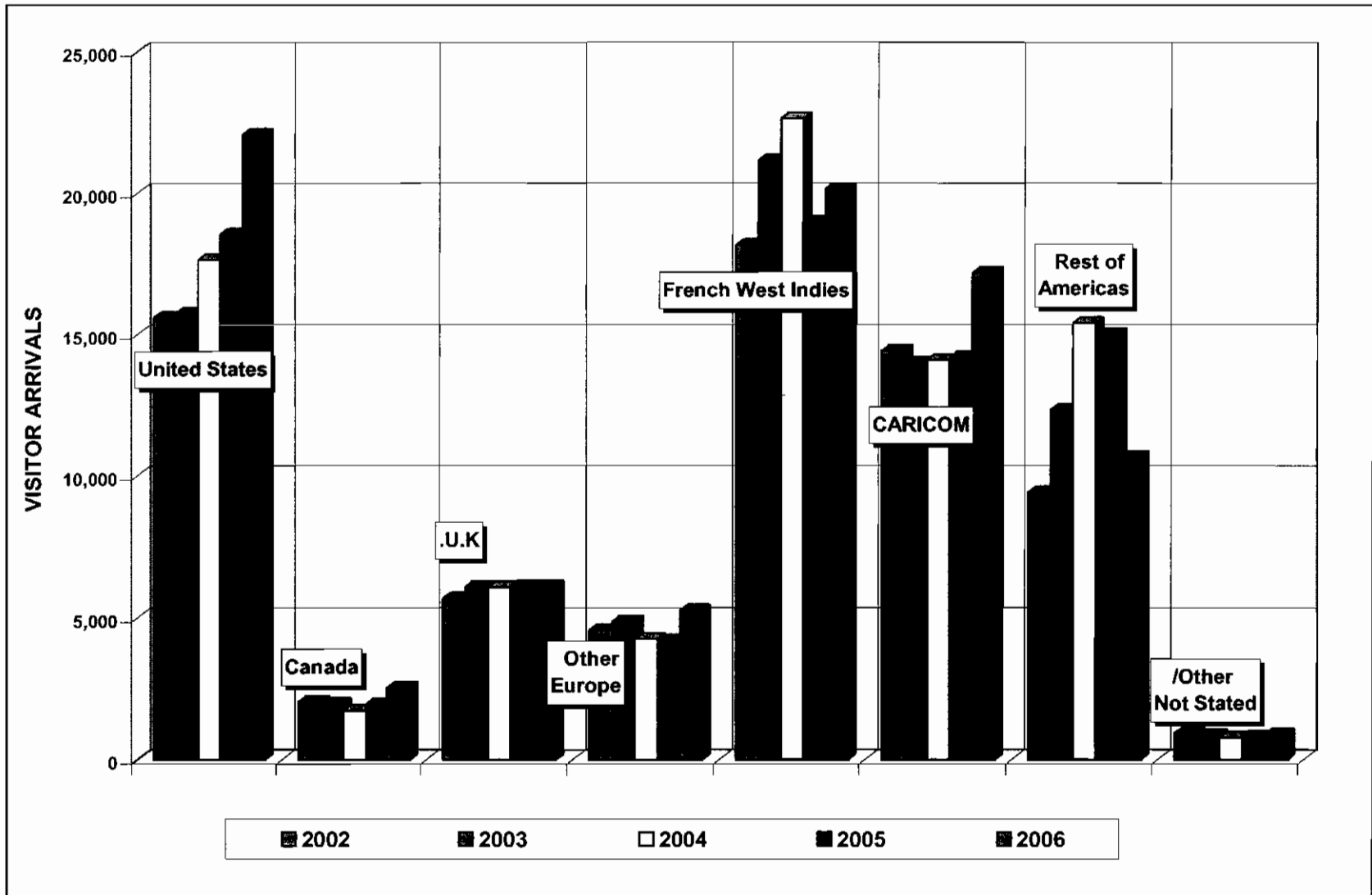

VISITOR ARRIVALS: 1997 - 2006

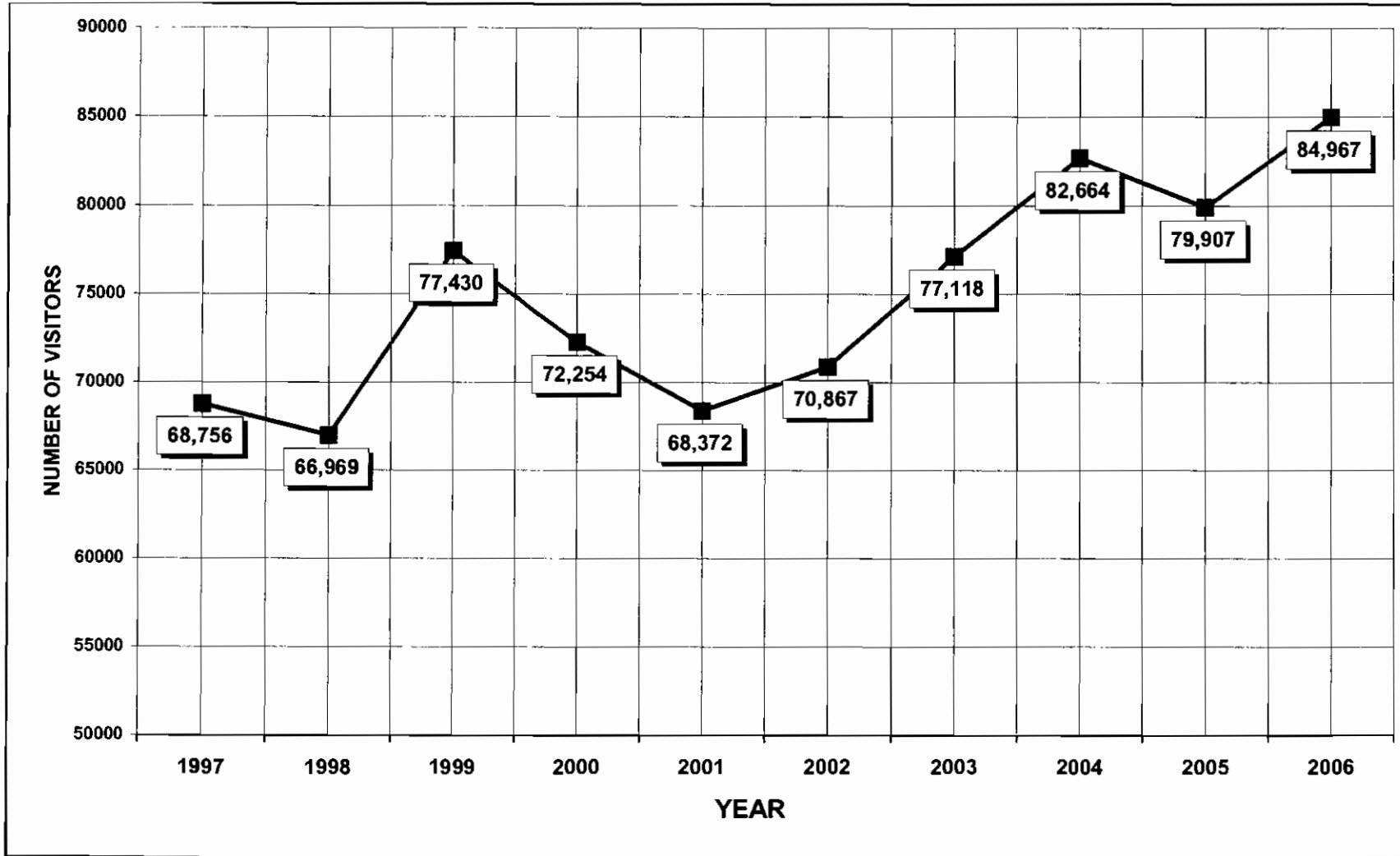

2002 - 2006

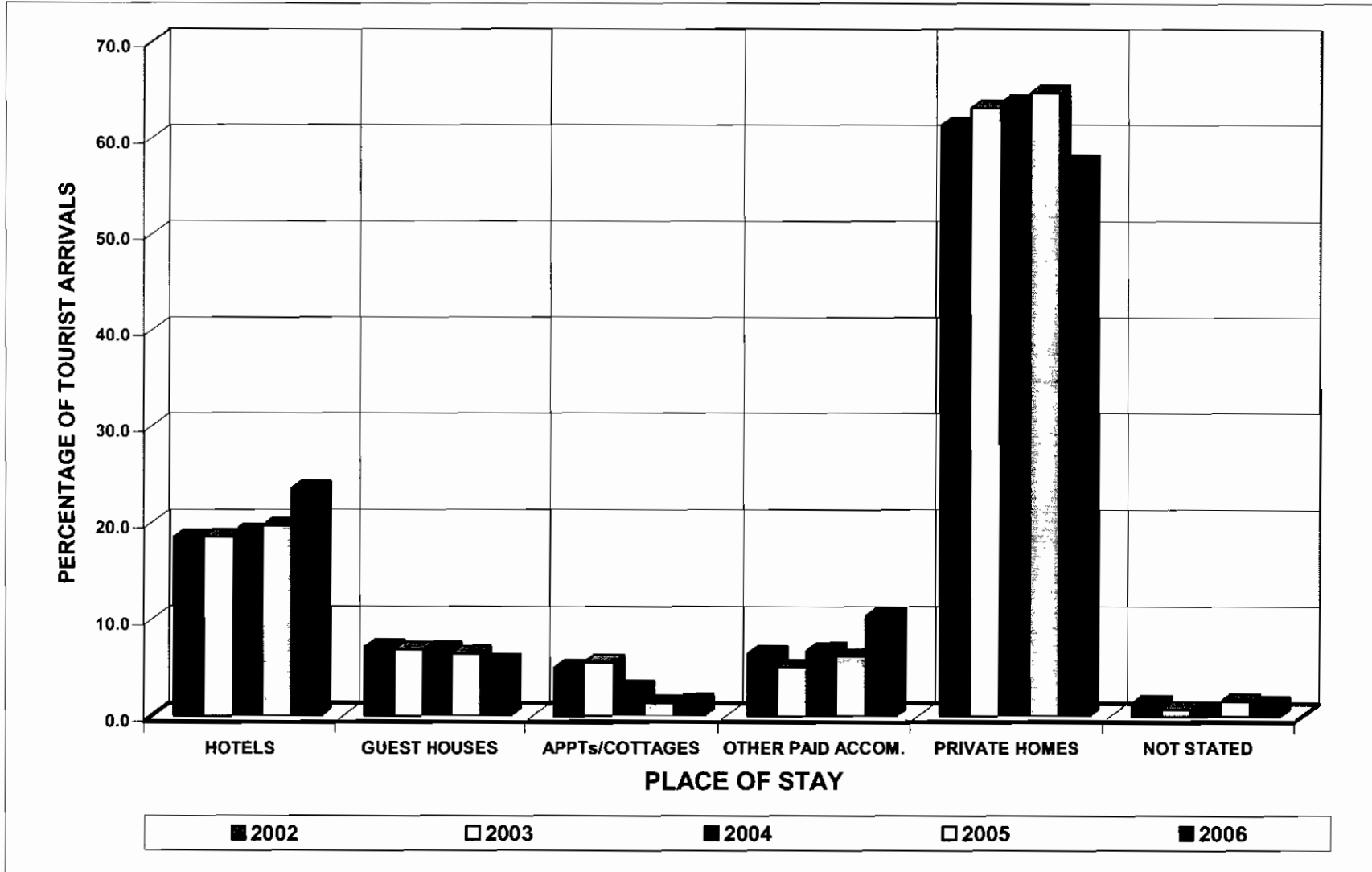

2002 - 2006**

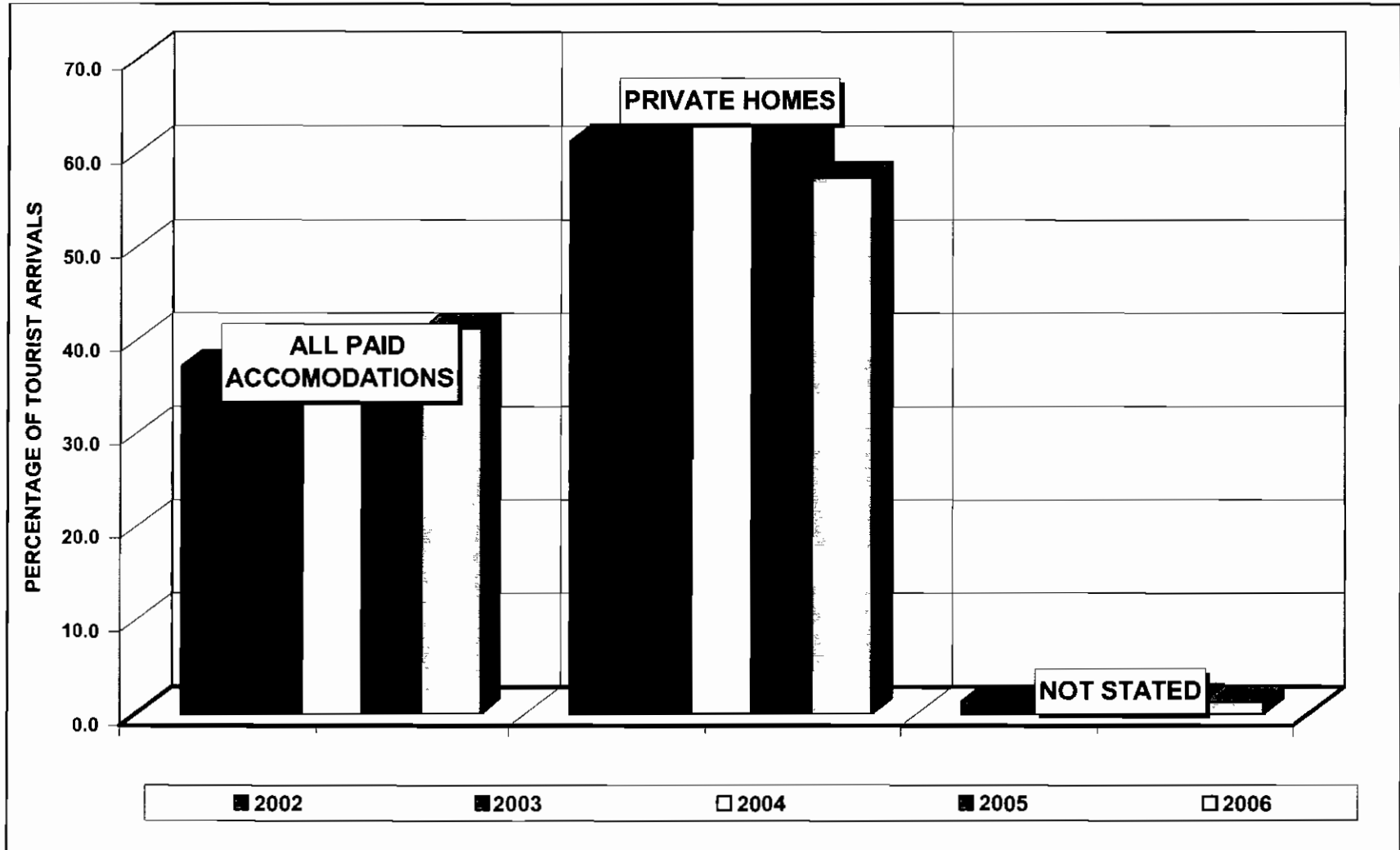

2006

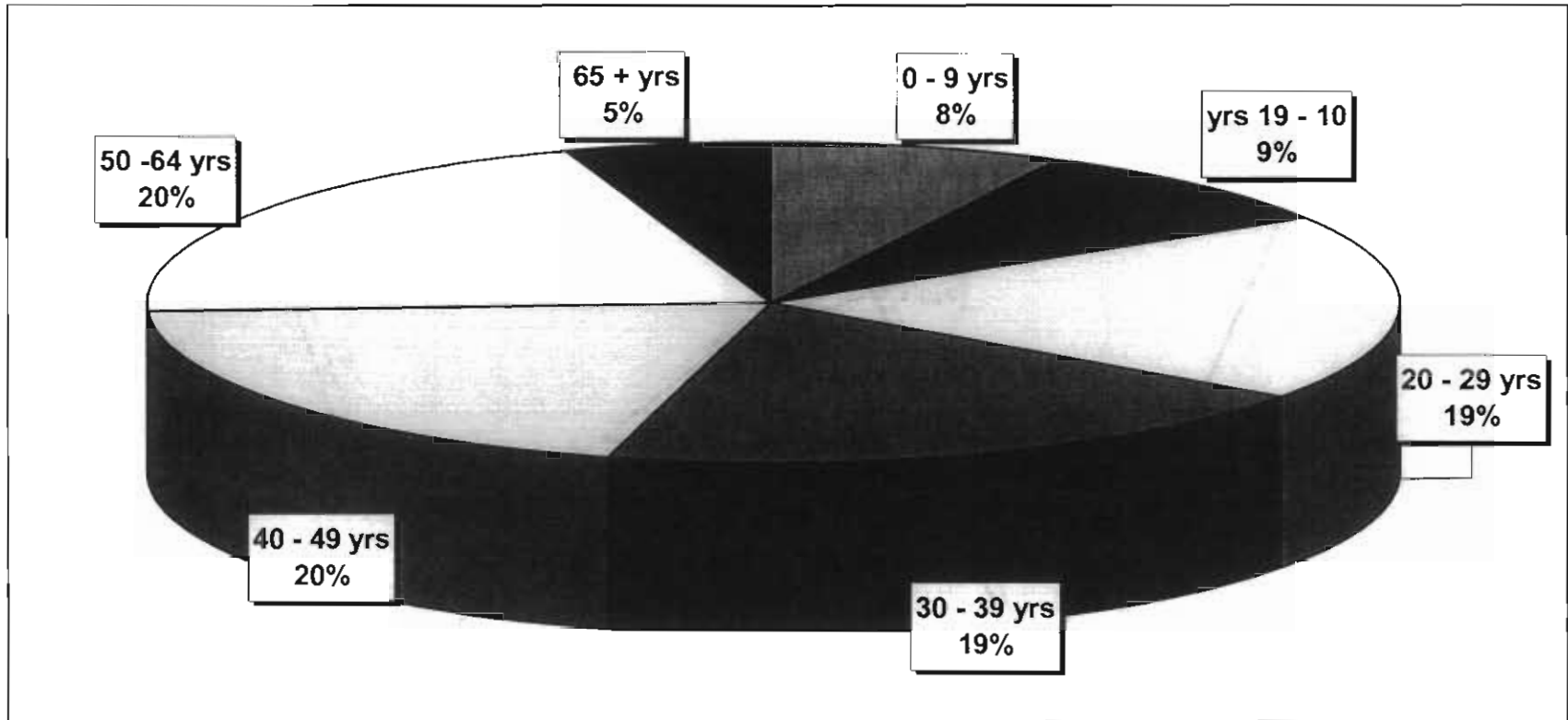

NUMBER OF EXCURSIONISTS: 1998 - 2006

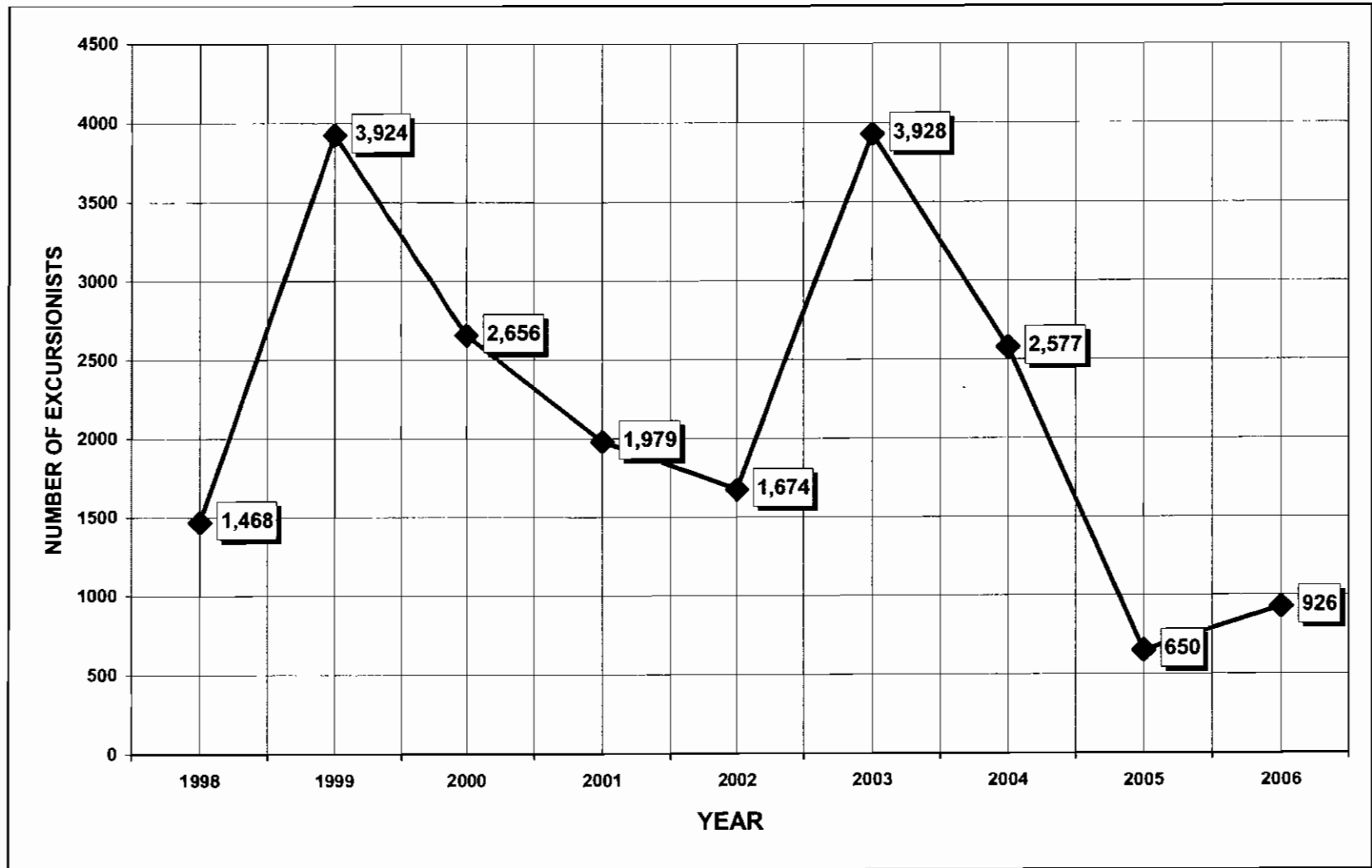

1998 - 2006**

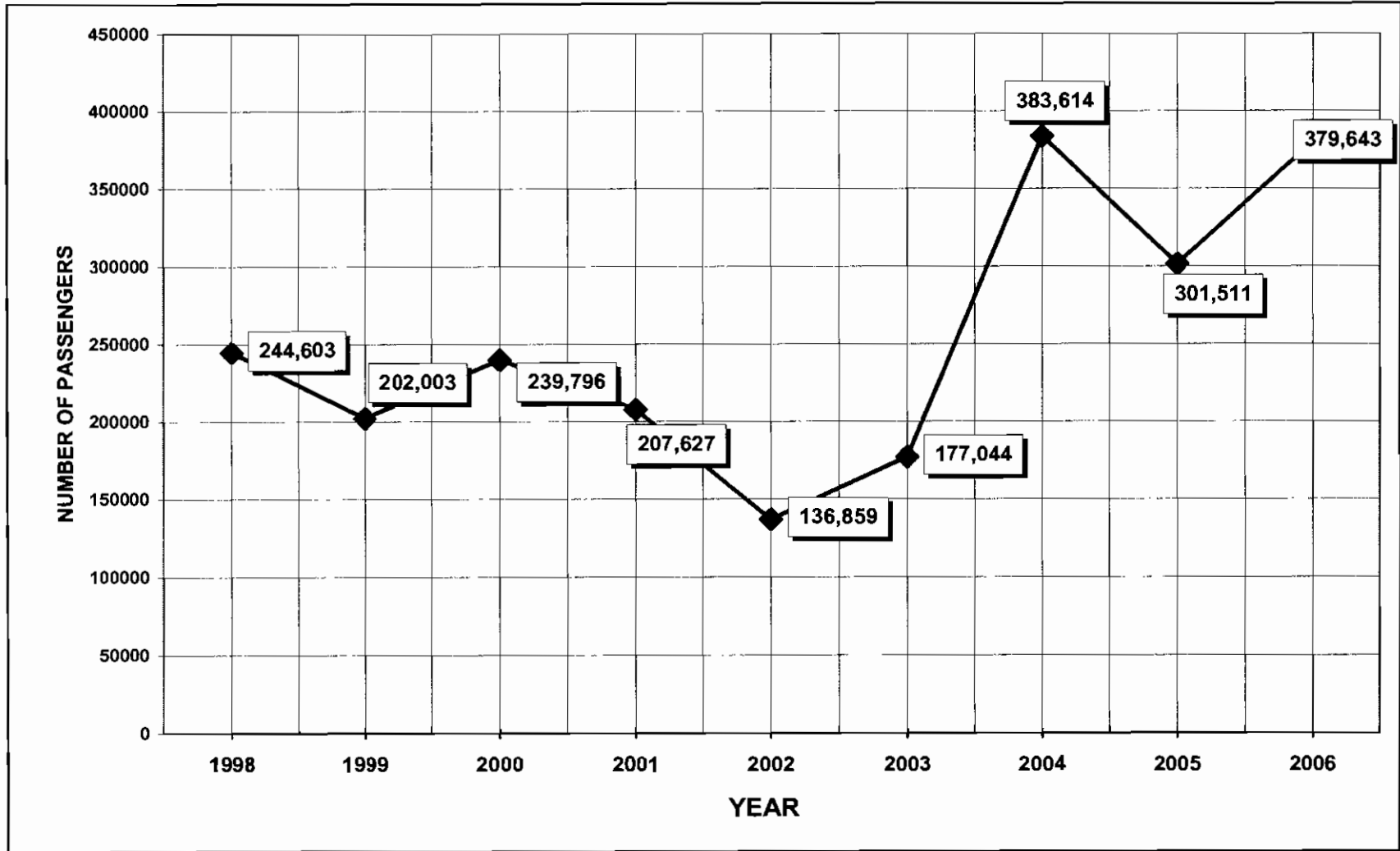
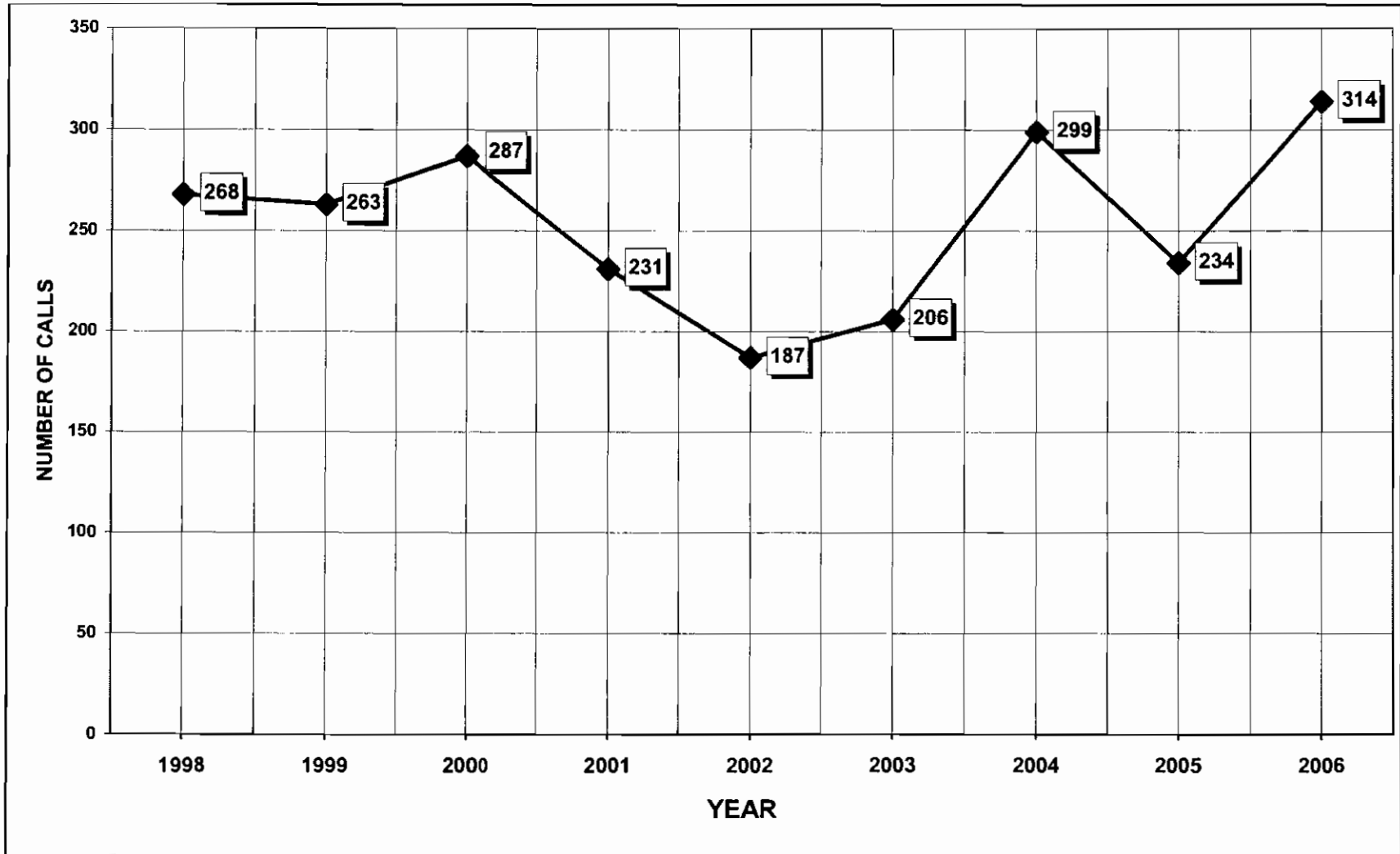


CHART 9
